Institute of Education Science What Works Clearinghouse (WWC)	Registry of evidence-based practices in education. SAMHSA Evidence-Based Practices Resource Center	Resources and tools for incorporating evidence-based practices. Provides resources for treatment, prevention, recovery and mental health. https://www.samhsa.gov/libraries/evidence-based-practices-resource-center	Does not offer a rating of programs
Washington State Institute for Public Policy (WSIPP)	Registry of cost-benefit analysis of public health programs, with a focus on public policies. https://www.wsipp.wa.gov/benefitcost	Cost benefit analysis for each listed program or policy
Athena Forum Community Library	Resources and tools from various sources focused on substance misuse prevention. https://theathenaforum.org/prevention-101/community-library	Does not offer a rating of programs
