LEGISLATIVE UPDATE

H108

The Senate floor unanimously passed H108. The Governor signed the bill on March 23

H108 will give prescribers and pharmacists the ability to prescribe Naloxone to third parties, such as family members. It also addresses civil and criminal liability

issues. In essence, it will allow a family member to go to a pharmacy and receive Naloxone if they thought there was a possibility their loved one might overdose on an opioid.

S1146aa

On March 24, the Senate voted 22-12 to pass \$1146aa to the House State Affairs Committee. On March 30, the House State Affairs committee failed the bill on a tie 8-8 vote. On April 1, the committee voted to reopen the matter for discussion and will vote on April 2, 2015.

S1146aa seeks to decriminalize the possession or use of cannabidiol (CBD) oil, if the CBD meets requirements set forth in the bill.

S1156

On March 24, the Senate unanimously passed S1156. The bill is currently awaiting a hearing in the House State Affairs committee.

S1156 would give the Department of Health and Welfare the authority to administer an Expanded Access Program (EAP) for the drug Epidiolex®. Epidiolex® is 100% cannabidiol (CBD) oil that is currently undergoing FDA clinical trials. The EAP will provide those suffering from intractable epilepsy who have not responded to traditional therapies the ability to obtain the drug at no cost. The EAP will contribute to the body of research on treatments for intractable epilepsy.

PROGRAM SPOTLIGHT: NEZ PERCE TRIBE

The Nez Perce (NP) Tribe's Students for Success Program has been in existence since 1995 and is in the NP Tribe's Education Department. The Program Director is Abraham Broncheau and the program is staffed by three full-time staff and one part-time.

Current projects include Good Health and Wellness in Indian Country, Tobacco Control, Tribal Youth Program Case Management, Life Skills Training, and Traditional Games (physical activity).

Students for Success (SFS) aims to provide and maintain a safe and healthy school environment, prevent the use of alcohol and other drugs and violence through comprehensive prevention programming and provide early intervention for children and youth at risk. SFS also strives to promote cultural identity and wellness with the notion in mind that "culture is prevention". SFS provides youth with the opportunities for selfgrowth and promotes student achievement for individuals to become contributing members to the 'Not A Replacement' anti-smoking tribe, government and their communities.

Students for Success has also established and maintained a strong connection between the schools and communities in the area and will make it a priority to sustain these relationships to further enhance our ability to change the cultural norms associated with substance abuse, tobacco, and health and wellness.

DRUG TRENDS: POWDERED ALCOHOL



Powdered alcohol, otherwise known as palcohol, was recently approved by Congress despite concerns from both political parties.

Palcohol is an alcoholic beverage that has been made into a powder, and which can be added to any liquid to make a fully alcoholic beverage. It can retain the specific flavor of the particular type of alcohol that it's produced from, such as vodka or

rum, as well as mixed drinks such as a margarita. It's easily transported in bags or pouches.

Lipsmark, the company that makes palcohol, until recently advertised the product as an option to defeat alcohol prohibitions at sports stadiums, and as a way to get drunk instantly by snorting the powder. After criticism, the company removed the statements from its website.

Despite clearing a federal prohibition, palcohol must now be permitted at the state level, where it faces tough questions regarding safety, abuse potential, and the need for such a product.
