

PREVENTION FRAMEWORK
(SPF) GRANT

The Idaho Office of Drug Policy (ODP) is accepting applications for fiscal year (FY) 2015 Strategic Prevention Framework Grants (SPF). The Federal SPF grant has two goals:

- 1. Prevent the onset and reduce the progression of substance abuse, including childhood and underage drinking,
- 2. Reduce substance abuse-related problems in communities, and; Build prevention capacity and infrastructure at the State/Tribal/Territory and community levels.

The deadline for submission of completed applications is 5:00 PM MST on Monday, June 2, 2014. Late proposals will not be accepted.

## LEGISLATIVE UPDATE

The 2014 legislative session proved helpful to the ongoing prevention efforts in

Idaho. Several bills supported by ODP were passed by the House and Senate and signed by the Governor.

- House Bill 396 this bill requires any prescriber with a controlled substances license to register for the state's Prescription Monitoring Program. This database allows doctors, dentists, and other healthcare professionals to check a patient's prescription history to help reduce fraudulent prescription seeking or "doctor shopping".
- Senate Bill 1327 this bill amended existing law to allow schools to maintain a small supply of epinephrine auto-injectors in case a student suffers an allergic reaction.
- Senate Bill 1379 this bill amended existing law to add several controlled substances such as those known by the street names Smiles and N-bomb to those classified as Schedule I drugs.
